

**STATUTORY REGISTER**

REGISTER OF AUTHORISATIONS GRANTED BY THE LONDON ORGANISING COMMITTEE OF THE OLYMPIC GAMES LIMITED (“LOCOG”) PURSUANT TO PARAGRAPH 5 OF SCHEDULE 4 OF THE LONDON OLYMPIC GAMES AND PARALYMPIC GAMES ACT 2006 (the “2006 Act”)

The register has been divided into two sections. Part A relates to authorisations granted to specific individuals or organisations. Part B relates to classes of person or organisations to whom an authorisation has been granted.

**Definitions:**

“**London 2012**” or “**London Games**” means the Games of the XXX Olympiad to be held in London in 2012 and the Paralympic Games also to be held in 2012;

“**LOCOG**” means The London Organising Committee Of The Olympic Games Limited (registered number 5267819) whose registered office is at One Churchill Place, London, E14 5LN;

The “**2006 Act**” means The London Olympic Games and Paralympic Games Act 2006.

For the avoidance of doubt, authorisations granted pursuant to Schedule 4 of the 2006 Act relate only to the creation of an association with the London Games and do not confer a right to use trade marks or other designs, logos or trade names etc relating to London 2012.
