### **Minutes:**

The Minutes and Actions of the 23<sup>rd</sup> Olympic Board meeting were agreed.

### **Programme Progress Report:**

It was noted that good progress had been made across the four strategic objectives since the previous meeting.

### **Items Agreed by Correspondence:**

The Board noted the approval, via correspondence, of the changes the Olympic Delivery Authority had recommended to the White Water Centre in Broxbourne. David Higgins said that good progress was being made on site.

The Board also noted that approval would be sought, via correspondence, for the budget for the Commission for a Sustainable London 2012.

### **Beijing Olympic Torch Relay:**

Jude Woodward, the Mayor's Senior Policy Advisor for Culture, gave a presentation on the plans for the London leg of the Beijing Torch relay – including a summary of the proposed route of the relay, and details of the events that would accompany the torch's passage through London.

The Board noted the torch relay plans, and in particular the Metropolitan Police Service's close involvement with the security aspects of the event's planning.

### **Pre-Games Training Camps:**

Paul Deighton explained the work LOCOG had been leading to develop a pre-Games training camp guide. The Board were given details of the application and selection process that venues had been through, and a summary of those venues which had been successful in being shortlisted. The Board noted the plans LOCOG had in place to inform applicant venues, and to publicise those venues which had been successful in meeting the selection criteria.
